What is the OQ Rule?
In 1999, the Operator Qualification (OQ) final rule was issued, enhancing training requirements for pipeline operators.

The rule, which was adopted into the Code of Federal Regulations under Subpart N in 49 CFR Part 192 and Subpart G in 49 CFR Part 195, requires pipeline operators to document that certain employees have been adequately trained to recognize and react to abnormal operating conditions that may occur while performing specific tasks.
